This work, based on an oral testimony of a rural woman, engages with the multiple experience of trauma and retribution during the Second World War and after. Concentrating on 1942, and not 1947, this extraordinary memory defies the opposition between subject and agent, victim and victimizer.

A pioneering social history of a peasant community, this work focused on the diverse narratives that shaped a Jat identity in colonial Punjab in the late-nineteenth and twentieth centuries.
