## NOTIFICATION (REVISED)

As per the Guidelines (Clause 6.8 of the Lyngdoh Committee Recommendations), the Vice-Chancellor has constituted a "Grievances Redressal Cell (GRC)" with immediate effect. The committee has mandate for the Redressal of election related grievances, including, but not limited to breaches of the code of conduct of elections and complaints relating to election-related expenditure. The GRC shall serve as the "Court of Original Jurisdiction". The institutional head, i.e. the Vice-Chancellor shall have "Appellate Jurisdiction" over the issues of law and fact in all cases or controversies arising out of the conduct of the elections in which the GRC has issued a final decision. Upon review, the Vice-Chancellor may revoke or modify the sanction imposed by the GRC. In carrying out the duties, the GRC shall conduct proceedings and hearing necessary to fulfil those duties. In executing those duties they shall have the authority:

- (i) To 'prosecute' violators of any aspect of the code of conduct or the rulings of the GRC.
- (ii) To issue a Writ of subpoena to compel candidates, agents and workers and to request students to appear and give testimony, as well as produce necessary records.
- (iii) To inspect the financial reports of any candidates and make these records available for public scrutiny upon request.
- (iv) Any other grievances related to the conduct of the JNUSU elections.
